### SPANISH INVESTMENTS

The Spanish legal system is based on civil law, providing a familiar framework for investments in Latin America and making it an ideal business hub for investors and businesses with interests in the region. The special holding company regime (called ETVE) designed for investments in foreign countries is particularly advantageous for channeling investments into Latin America due to its multiple double tax treaties.

### RESIDENCE INCENTIVES

Residence by investment, known as the Spanish Golden Visa, allows foreign nationals to apply for a special visa that gives the right to live, work, and study in Spain, with access to Europe's Schengen Area. Alternatively, the expatriate tax regime (Beckham Law) allows employees or directors of companies who move to Spanish territories to be taxed as non-residents, and to be taxed on their income at a reduced fixed rate.
